1. EXPLANATORY NOTES

The Syllabus of the subject "International Investment Activity" is developed on the basis of the "Guidelines for the development and execution of Syllabus and Course Training Program of subjects", promulgated by order №37/po3 dated 16.06.15.

This training course is the theoretical basis of the body of knowledge and skills that form modern economic thinking in the field of professional management. Learning of this discipline aims to study processes of international investment businesses.
