INTRODUCTION

The Syllabus of the subject "Management of the Enterprise Ecomonic Activity" is developed on the basis of the "Guidelines for the development and execution of Syllabus and Course Training Program of subjects", promulgated by order №37/po3 dated 16.06.15.

This educational discipline of "Management of the Enterprise Ecomonic Activity" occupies an important place in the system of economic education and there is one of the profiling disciplines at preparation of specialists for speciality.

The aim of teaching of discipline of "Management of the Enterprise Economic Activity" is to couch the students of knowledge of theoretical management with production bases and practical ability to use different kinds and methods of objective estimation of economic processes and end-point, exposure of factors and backlogs of production for the ground of suggestion for the proper managerial decisions.

The tasks of study of educational discipline are:

to ground of strategy and tactics of development of enterprises;

to increase of scientifically-economic validity of businessplans;

objective and yeectopohhe research of implementation of businessplans and norms (in the process of their development); determination of economic efficiency of the use of material, labour, financial resources;

control after realization of requirements in relation to the commercial settling for services and exposures of internal backlogs at all stages of making of products;

to ground and test of optimal administrative decisions.

As a result of study of this educational discipline a student **must**:

to know a role and setting of economic analysis in control system;

principles of management of enterprise economic activity;

to be able:

to conduct the economic analysis of economic activity of enterprise;

to ground, on the base of the conducted economic analysis, concrete measures of removal of undesirable results for administrative decisions in economic activity.

Educational material of discipline is structured on module principle and consists of two classic educational modules namely: educational module №1 "Conceptual principles of management of enterprise" economic activity. educational module №2 "Managements of economic activity of enterprise" separate aspects, each of that is logically completed, relatively independent, integral part of the discipline, the mastery of which involves modular control work and analysis of the results of its implementation.

The discipline is based on the knowledge of such disciplines as "Macroeconomics and Microeconomics", "Economic Law" and it is the basis for studying such disciplines as: "Management Controlling", "International Business".

Theme 2.1.3. Management of company's current assets

General description of floating capital of enterprise. Indexes of efficiency of the use of floating capital of enterprise. Net circulating capital and current financial necessities of enterprise. An acceleration of circulating of turnover means is a major method of decline of current financial necessities of enterprise.

Theme 2.1.4. Management of company's labor resourses

Concept, classification and structure of personnel of enterprise. Management of labour of personnel the productivity. Determination of quantity of separate categories of personnel of industrial enterprise. Modern control system by a personnel. Motivation of labour activity of workers of enterprise.
